Rationale:

The purpose of technology use is to engage and inspire all to learn and celebrate achievements. Information Communication Technology (ICT) encompasses a vast array of online tools to increase skills, obtain information, further knowledge and liaise worldwide; providing exciting opportunities for learning.

To ensure that all use of ICT resources are legal, ethical and consistent with the aims and values of our school and the Department of Education and Training (DET) guidelines.

We believe the teaching of cybersafe, and responsible use and behaviour is paramount in the lives of students and is best taught in partnership between home and school.

Aims:

- To improve student learning through access to a variety of technology, online resources and forums.
- To develop skills in effectively working within an online environment.
- To ensure all members of the school community are safe technology and online users.

Implementation:

- Support access by students to the widest variety of technological resources available, accompanied by the development of skills necessary to analyse, interpret and evaluate information.
- An ICT coordinator will oversee the technical support technician in managing online correspondence and access, maintenance of the school's website, filters, and all other issues related to online access.
- The school ensures that information published online is of a high educational standard; meeting legal requirements and standards in relation to copyright, security, safety and decency.
- Online access rights will be defined for different user levels.
- Technological privacy and security will be recognised and respected at all times.
- Staff and student communication forums will be through a Google class or individual account, under teacher and school supervision. Google accounts will be password protected.
- Staff and students will have censorship filtered online access to the Internet at all time.
- Students are responsible for notifying of any inappropriate material, so that access can be blocked.
- Staff are responsible for ensuring all online usage and published material is screened for appropriateness; notifying the ICT coordinator of inappropriate material, so that access can be blocked.
- Staff are responsible for providing adequate supervision of students during class time and recess/lunchtime management practices, to ensure appropriate use of online resources.
- ICT access will be removed if inappropriate material is published, or failure to notify the ICT coordinator of inappropriate material. Supportive measures will be put into place to ensure understanding of how to use technology appropriately in the future.
- Signed parent and student consent is required to be completed upon school enrolment in order to gain access to technology, online resources and forums or to publish work.
- Parents are responsible for their child's use of technology at home. The school will not be held responsible for the inappropriate actions of students outside the school property. If concerns were to arise at school, stemming from the misuse of technology in the home, the teacher and/or principal will consult with those involved, including parents to help develop a resolution.

I allow the school to review my child(ren)'s online account, files and storage in order to determine the appropriateness of specific usage or saved documents in accordance with departmental guidelines and policies.

- Promptly tell my teacher if I have received a message or obtained information that is inappropriate.
- Not forward photographs of myself or others, unless deemed educationally appropriate by my teacher.
- Seek to understand the terms and conditions of websites and online communities.
- Not steal or copy someone else's work or ideas online and present them as my own.
- Be responsible and aware that content uploaded or posted stays with me forever.

I understand that breaches of the Student Agreement will see me lose ICT access for a period of time determined by my teacher and/or Principal.
