

2021 Student Fee Information



Dear Parents/Guardians,

CSPS School Strategic Plan focuses heavily on improving learning outcomes for all students in literacy, numeracy and engagement in their learning.

With the challenges of 2020 in mind, we have worked extremely hard behind the scenes to ensure that the 2021 Student Fees are at an absolute minimum and at a reduced cost.

There are two significant changes to 2021:

- 1. Most families are in credit for events cancelled in 2020. Family statements were emailed today containing the credit amount. This credit can be used towards your 2021 school fees (see remittance form for specific information).*
- 2. Families that paid their 2020 fees will receive any unused booklist items (sent home today). We would like to provide you with the option to use these items again in 2021. Please indicate on the remittance form if you will keep these items at home (and require the school to purchase 2021 booklist items) or you will purchase all other remaining items yourself.*

Full payment or part-payment (\$100.00) is required by **Friday, 11 December 2020** per student (not per family). If you select part-payment, the remaining balance is required by **Friday, 22 January, 2021**.

If you are experiencing hardship, please contact the office to arrange a payment plan by **Tuesday, 8 December 2020**. All Parent Payment Plans require a \$50 per student minimum deposit. Parent Payment Plans will not be accepted after this date.
